The recognition, which is a respected tradition for twenty-six years, will be presented to three distinctive members on Saturday, October 21, 2017, during the FHBA Fall Leadership Conference at the Sawgrass Marriott Golf Resort & Spa in Ponte Vedra Beach, Florida.

Bill Paul

For more than 30 years as a builder, developer, and owner of Woodland Group, Inc., Bill Paul's greatest dedication to the building industry is his leadership and direct involvement in securing the future of the workforce. Paul, while managing a successful career, volunteers and supports funding for the Home Builders Institute (HBI) and its programs, an organization dedicated to the education, career development, training and placement of those serving the building industry; takes active roles in working with community planning and regulatory offices to create builder-friendly environments; and champions student training based on industry standards. Through his leadership, Paul has helped inspire and educate the next generation of housing industry professionals.

Mike Rahn

As a Residential Mortgage Lender for over 28 years, Mike Rahn has assisted hundreds of families obtain the American Dream of home ownership, while tirelessly advocating for the home building industry.
